# Young Catholics Anticipate World Youth Day

This summer, more than 20 adults from across the Diocese of Grand Rapids will travel to Lisbon, Portugal for World Youth Day. The experience is more than a mere vacation, however. This worldwide celebration with Pope Francis brings together millions of young people aged 18-34 to worship together, providing a sense of unity with the Catholic Church. Attendees of the experience are called pilgrims, reflecting a journey to a special place for a religious reason.

Pilgrim Devin Jenkins is looking forward to the new experience. "I want to know God deeper, in a different light, and see him from a different perspective," he said. "To have the opportunity to meet other Catholics from all over the world would shine a light on a new part of Jesus's love and beauty that I have not yet seen. This is a once-in-a-lifetime experience for me."

Devin converted to the Catholic faith two years ago and attributes his faith journey, in part, to the power of communal experiences. **"There are so many people** who want to grow themselves, help others, and change people's lives," he said. "When you bring that together, that's such an intoxicating, amazing environment." Through experiences on retreats, attending March for Life, and participating in local Catholic groups, Devin's faith has always been inspired by those around him. He sees World Youth Day as the ultimate environment in which to have an encounter with Christ. "With this trip, I'll be with all these people who have the same beliefs, ideals, and values. It doesn't matter where you are, all of these people are gathered in one spot for Christ." Devin is one of ten pilgrims receiving a scholarship through the Catholic Foundation's Leaders in Generosity Grant. This grant, made possible by the generous support of the local business community, is giving these pilgrims the opportunity to grow in faith together and to share with the world the hopes of young adults who are committing their lives to Christ and His Church.

When pilgrims return home to their faith communities, Devin believes their example will inspire those around them. "Young adults can be a shining light and show that we are strong and our faith is true. If people do that, take it home, and embrace it, it'll be life changing for a lot of people."

### AN INVITATION FROM GOD

While stopping for coffee, a World Youth Day flyer caught the eye of Eduardo Gomez. Eduardo skimmed the flyer and later shared, "I felt the chills start at my shoulders and run down all the way to my fingertips reading the header of the ad." He got his coffee and went on his way to work, reflecting on the World Youth Day pilgrimage he took to Krakow, Poland in 2016.

He didn't think much of the flyer in the following days, but he felt a small spark, an invitation from God. A month later, Eduardo received his second invitation from God when his parish, St. Francis de Sales (Holland), made an announcement that they were holding an informational meeting on World Youth Day. His fond memories from Krakow and his belief the pilgrimage will "allow us to grow our trust, confidence, faith, and relationship with God" led Eduardo to say "yes" to God's invitation.

#### **VOICE OF THE YOUTH**

Clara Thelen, a 2023 high school graduate, views World Youth Day as a unique opportunity for the voices of Catholic youth to be heard. "In a world where faith is so small, to be able to gather with so many youth who share the same religion is extremely rare and will be so fruitful," she said. **"Our voice has a place and a purpose in our world today."** 

Clara is looking forward to exploring the significance of youth in our world today, deepening her relationship with the Lord, and immersing herself in Portuguese culture. She said, "I truly believe that this is a once-in-a-lifetime opportunity that God has put in place for me."

### Joyful Response to New Parish Legacy Fund

St. Patrick – St. Anthony Parish has been a tangible and spiritual blessing to countless brothers and sisters in Christ throughout the tri-cities (Grand Haven, Spring Lake, and Ferrysburg) for more than 165 years.

However, until recently, the parish had not formalized a way to financially support its mission in perpetuity. Rev. Chuck Schwartz shared his philanthropic vision with the parish finance council, expressing his belief that it was essential for the parish to commit to its long-term vitality by establishing a parish legacy fund. He shared, "By creating a parish legacy fund, we are inviting parishioners to support the parish long after they have gone home to God. Current parishioners, in fellowship with future generations of parishioners, can help ensure the vital work of the parish for years to come."

The parish formed a committee of staff and lay leaders to help bring Father Chuck's vision to life. Last fall, the parish established the St. Patrick – St. Anthony Parish Legacy Fund, a permanent endowment that distributes a portion of the fund's balance to the parish each year to financially support three priorities:

- 1. Formation and worship programs
- 2. Christian service ministry
- 3. Facility maintenance and capital improvements

These priorities reflect a commitment to the parish's Catholic mission today while ensuring that the funds

are prudently invested and stewarded for the future of the parish through a partnership with the Catholic Foundation. In order to not compete with annual fundraising efforts, the parish legacy fund invites parishioners to consider leaving a financial gift upon their passing (also known as a planned gift).

With the fund established, parish staff, the finance council and the Catholic Foundation worked collaboratively to introduce the giving opportunity and raise awareness within the parish. Together, they created announcements and educational materials, invited and met one-on-one with donors, and hosted three informational sessions at the parish. Parishioners enthusiastically supported the invitation. **"We wanted to express our gratitude to the Lord and to this parish family,"** said Mark and Phyllis Ventocilla. **"We are pleased the parish is moving in this direction and are happy to participate."** 

"Including the parish in one's own personal estate planning really resonated with our parishioners," stated Colleen Mitchell, a parishioner and member of the finance council. "By publicizing this opportunity, we learned right away that several parishioners had already made the decision to include our parish in their legacy giving plans but did not know how to move forward. We listened to parishioners share how important and valuable their parish family is to them, and that they want to ensure that future generations will also be able to experience the love of Christ among a financially-supported church." In total, 31 participants attended the informational sessions or had a confidential conversation with a parish representative. Others discerned privately and consulted with their professional advisors. The fund was promoted consistently for several weeks, resulting in several new endowments and multiple known planned gifts. The parish's efforts were so successful they elected to host a celebratory brunch with Father Chuck, inviting everyone who made or is considering making a gift.

Jimmy Beauchamp, parish administrator, envisions the potential this fund will have on the parish's operation over the long term. "We are so grateful for our parishioners who have chosen to support our legacy fund today or in their estate plans. A strong endowment will simply make our parish more financially stable for the next generation," he reflected.

The fruits of these efforts were made possible through the work of Holy Spirit, Father Chuck's leadership, prayer, planning, and using the gifts and talents of those around the parish. "We have found the Catholic Foundation of West Michigan to be an excellent resource and partner to educate our parishioners of their options for participating in our new parish legacy fund, and to actively steward, in perpetuity, the generosity from our parishioners," said Mitchell.

St. Patrick – St. Anthony envisions forming a "Legacy Society" of parish benefactors to recognize their generosity, pray and celebrate together, honor those who preceded them, and encourage others to join. "Participants have already grown together in communion with one another, and I'm confident the Holy Spirit will inspire additional parishioners to include the parish in their legacy giving plans over time," said Father Chuck.

As Father Chuck transitions to his new assignment as pastor of Assumption of the Blessed Virgin Mary Parish (Belmont), his leadership in establishing the parish legacy fund and laying the groundwork for the Legacy Society has set the parish up for long-term strength. **"It is important for us to remember that the goal is salvation of souls, to inspire every heart to know, love, and serve Jesus Christ," said Father Chuck. "If we keep that idea in the forefront, this community will continue to be a spiritual home and a haven of life, love, beauty, and truth for years to come."**  "It has been a blessing to see people share their giving intentions joyfully as an expression of their faith."

# **Do your children see you give?** Christian Stewardship

With a swipe of a card at the gas pump, the tap of a phone at the grocery store, and digital billing set on autopay, how do our children see us interact with money? Prior generations saw piggy banks, parents sitting down to balance their checkbooks, and offertory envelopes dropped in the basket each Sunday. Today, with all the conveniences of managing money online, do your children see you give?

Our Catholic faith teaches us that the home is well suited for education in the virtues, and every parent wants to raise children who share. Yet, sharing is no different than any other learned behavior – it must be taught. After all, children mimic what they see, and their parents are their primary teachers. A child who never sees a parent place an envelope in the offertory basket or volunteer at a parish event could grow up thinking, "My parents never supported the Church. Why should I?"

Since modern conveniences may also have some unintended drawbacks, make intentional time to talk with your children about how you give to the parish — both of your time and money. Your example demonstrates to them your humility, responsibility, and joy in following Jesus. And, by openly discussing the causes and charities your family supports, you can inspire a spirit of generosity within your children as they journey through life. Don't forget to ask them if they have any causes they would like to support – their answers might surprise you!

While legacy planning is a great way to contribute to causes you care about and create a plan that aligns with your value, only about a third of Americans have an estate plan.

### Don't think their estate is large enough to matter.

Anything you own outright (including a car or home) can be considered your "estate." In fact, research shows over 90 percent of wealth is held in non-cash assets. If you don't have a will or a named beneficiary, whatever you own will likely end up in the probate process and cause headaches for those you love.
